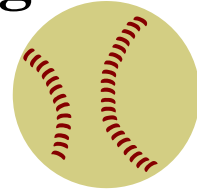

## Alton Parks and Recreation Adult Co-Ed Softball League Contract for Participation Player's Code of Conduct



- I recognize that this is a recreational league designed for players to have fun.
- I will display good sportsmanship at all times.
- I will stay in control of my emotions regardless of how competitive a game may become.
- I understand that aggressive behavior toward the officials, spectators or other teams may result in my dismissal from the league. I understand the Ejection Rule, and understand that my behavior has consequences. If I am ejected from the game I understand that I am not permitted to play in my team's next game. I understand that if I am ejected from a game a second time that I will be terminated from the League based on a Board of Director's Vote.
- I am aware that my behavior during a game could have a negative effect on my team's ability to continue to participate in the league.
- I understand that alcohol and tobacco products are prohibited at all fields that are utilized by the Parks and Recreation Department and I pledge to refrain from their use when participating in Parks and Recreation sponsored events. I understand that if I choose to use prohibited products on Town property I will be removed from the league.
- I will not wear clothing with offensive words or symbols to games. If the official in charge feels my clothing is inappropriate I will be asked to change or turn my shirt inside out.
- I understand that the Parks and Recreation Commission have the right to remove a player from a team roster at anytime if it is deemed to be in the best interest of the league.
- I will use the proper chain of command in the following order to report a complaint: (1) Coach; (2) Umpire; (3) Parks and Recreation Director; (4) Parks and Recreation Commission.
