On Page 7, the last sentence of the next to the last paragraph reads "The he learned for the first time..." and should be "**Then** he learned for the first time..."

On Page 11, the 4th line of the first paragraph reads "...placed on the variance, and them it will have..." and should be "...placed on the variance, and **then** it will have..."

On page 16, the middle line of the last paragraph reads "...here is the best proposal they have hear so far." It should read "...here is the best proposal they have **heard** so far."

On page 20, the third line from the bottom of the second paragraph reads "...parking; they already know that whether they are inconformity with parking..." and should read "...parking; they already know that whether they are **in conformity** with parking..."

On Page 20, the last paragraph reads "P. Monzione said they would want to hear the Board say they don't need it before they withdraw it, but the question is whether they are willing to withdraw it before they say that." To clear up ambiguity there, it should read "P. Monzione said **the applicant** would want to hear the Board say they don't need it before they withdraw it, but the question is whether **the applicant** is willing to withdraw it before **the Board says** that."

On Page 21, the fourth line from the bottom of the next to last paragraph reads "...there that perhaps they (the applicant) does not need..." and should read "...there that perhaps **the applicant** does not need..."
